AWARD OF S\$4.3 MILLION SUBCONTRACT WORKS – PRE-FABRICATED MULTI-TRADE SERVICES SYSTEM WORK IN RESPECT OF THE DEVELOPMENT OF 6 BLOCKS OF 7-STOREY HEALTH CAMPUS COMPRISING ACUTE HOSPITAL, SPECIALIST OUTPATIENT CLINICS, COMMUNITY HOSPITAL, NURSING HOME AND 4 BASEMENT LEVELS WITH 2 LEVELS FOR CARPARKING AT WOODLANDS

DLF Holdings Limited (the “**Company**”, and together with its subsidiaries, the “**Group**”) is pleased to announce that its wholly-owned subsidiary, Acmes-Kings Corporation Pte. Ltd., has on 3 September 2019 secured a S\$4,285,000 subcontract works – Pre-Fabricated Multi-Trade services system work from Tech Onshore MEP-Prefabricators Pte. Ltd. in respect of the development of 6 blocks of 7-storey health campus comprising acute hospital, specialist outpatient clinics, community hospital, nursing home and 4 basement levels with 2 levels for carparking at Woodlands (the “**Contract**”).

The Contract for the subcontract work shall commence in September 2019 and is expected to complete in first quarter of 2021.

The Contract will contribute to the revenue of the Group but is not expected to have any material impact on the earnings per share or the net tangible assets per share of the Group for the financial year ending 31 December 2019.

Save for their respective shareholdings in the Company, none of the directors, controlling shareholders or substantial shareholders of the Company, has any interest, whether directly or indirectly, in the Contract.
