"In February 2019, the Group received a notice of termination of the Maldives Project from the project owner. In March 2019, the Group received **three Notices of Employer's Claim** from the project owner claiming an amount of **approximately** S\$4million from the Group in respect of compensation for delays in Phase 3B of the Maldives Project, reimbursement of costs of engaging a new contractor to complete unfinished works of the Group, and payments made to some suppliers and sub-contractors of the Group. **Under a Final Financial Settlement Statement entered into between the project owner and the Group in September 2019,** the S\$4 million claim amount **was** fully offset **against** the Group's S\$4 million trade receivable due from the project owner as at 31 December 2018."

Save for the above, there are no other changes to be made to the FY2019 Result Announcement.
