**ISSUE AND ALLOTMENT OF 186,415 ORDINARY SHARES IN THE CAPITAL OF THE
COMPANY PURSUANT TO THE PERFORMANCE SHARE PLAN**

The board of directors (the “**Board**”) of OIO Holdings Limited (the “**Company**” and together with its subsidiaries, the “**Group**”) wishes to announce that the Company had, on 1 April 2022 issued and allotted an aggregate of 186,415 new ordinary shares (the “**New Shares**”) in the capital of the Company pursuant to the Performance Share Plan (“**PSP Plan**”).

The New Shares will rank *pari passu* in all respects with the existing shares in the capital of the Company. The New Shares are expected to be listed and quoted on the Singapore Exchange Securities Trading Limited on or about 5 April 2022.

Following the issuance of the New Shares, the Company’s issued and paid-up share capital has increased from 186,849,739 shares to 187,036,154 shares.
