ISSUE AND ALLOTMENT OF 600,000 ORDINARY SHARES IN THE CAPITAL OF THE COMPANY PURSUANT TO THE OIO PERFORMANCE SHARE PLAN

The board of directors (the “Board”) of OIO Holdings Limited (the “Company” and together with its subsidiaries, the “Group”) refers to the announcements dated 23 May 2023 in relation to the grant of share awards pursuant to the OIO Performance Share Plan (“PSP Plan”) and wishes to update that the Company had, on 23 May 2024 issued and allotted 600,000 new ordinary shares (the “New Shares”) in the capital of the Company upon satisfaction of the time-based service condition by the participant, Yusaku Mishima, who is the Executive Chairman of the Company.

The New Shares will rank pari passu in all respects with the existing shares in the capital of the Company. The New Shares are expected to be listed and quoted on the Singapore Exchange Securities Trading Limited on or about 9.00 a.m. on 27 May 2024. Following the issuance of the New Shares, the Company’s issued and paid-up share capital has increased from 187,360,841 shares to 187,960,841 shares.
